Scope:

The California Consumer Privacy Act of 2018 (CCPA) gives certain consumers that reside in California ("California Consumers") the right to know what categories of Personal Information Aquestive Therapeutics, Inc. ("Aquestive") collects about them and for what purposes we use and share that information. This Privacy Notice supplements Aquestive's United States Corporate Website Policy Statement.

As used in this Privacy Notice, "Personal Information" means information that identifies, relates to, describes, is reasonably capable of being associated with or could reasonably be linked, directly or indirectly, with a particular individual or household. Personal Information includes, but is not limited to, the categories of Personal Information identified below if such information identifies, relates to, describes, is reasonably capable of being associated with, or could be reasonably linked, directly or indirectly, with a particular individual or household.

Collection of your Personal Information:

- loT and Sensor data, i.e. smart device records, product/device generated data
- Geolocation data, i.e. mileage for reimbursement of sales representatives
- Children's data from parents and guardians, i.e. child's name, product usage

Requests to Exercise Your Rights

Under the CCPA you have a right to request information about our collection, use, and disclosure of your personal information over the prior 12 months, and ask that we provide you with the following information:

1. Categories of and specific pieces of personal information we have collected about you.

- 2. Categories of sources from which we collect personal information
- 3. Purposes for collecting personal information.
